PRAYER :-

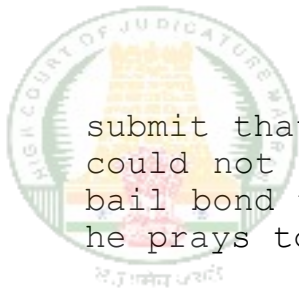

Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Criminal Side), this petition is ordered and the time for executing the sureties and for depositing the said amount is extended by 10 days from the date of receipt of a copy of this order as a last chance.
