PRAYER :-

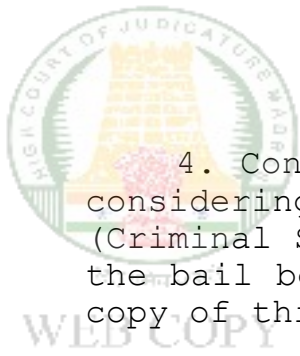
To extend the time for production of sureties made in Crl. OP. (MD) No.7747 of 2019, dated 07.06.2019 on the file of this Honorable Court.

The petition has been filed to extend the time granted by this court in CRL OP (MD) No.7747 of 2019, dated 07.06.2019, for producing the sureties and for executing the bail bond.
