Criminal Original Petition filed under Section 482 of Criminal Procedure Code, to direct District Munsif cum Judicial Magistrate Court, Cheranmahadevi, Tirunelveli District to dispose the C.C. No.1 of 2017 as expedite of trial by framing a time stipulation in accordance with law.

2. This Court is satisfied with the reasons assigned by the District Munsif cum Judicial Magistrate, Cheranmahadevi, Tirunelveli, in the letter in D.No.421/21 dated 12.03.2021 addressed to the Registry of this Court.

3. In the circumstances, the District Munsif cum Judicial



Magistrate, Cheranmahadevi, Tirunelveli, is directed to dispose of C.C.No.1 of 2017 as expeditiously as possible.
