Prayer in WP(MD). 6981/ 2016 :

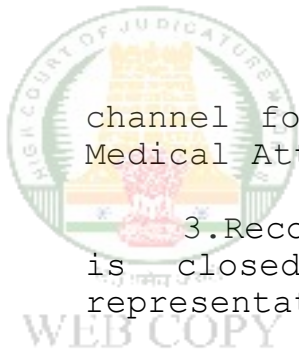
