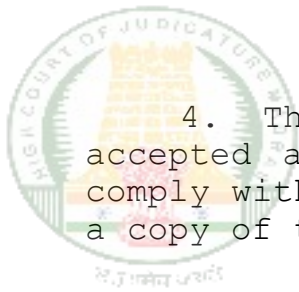
For Bail in Crime No. 350 of 2019 on the file of the Respondent Police.
