The petitioner is permitted to deposit a sum of Rs.10,000/- (Rupees Ten thousand only) to the credit of crime number 109 of 2019 on the file of the learned Judicial Magistrate, Sankarankovil as per the order passed by this Court in Crl.O.P(MD) No.7142 of 2019 dated 16.05.2019 on or before 01.08.2019.

3. Post the case before this Court on 02.08.2019 ."

As per the order passed by this Court on 24.07.2019, the petitioners have paid a sum of Rs.10,000/- (Rupees Ten thousand only) to the credit of crime number 109 of 2019 on the file of the learned Judicial Magistrate, Sankarankovil on 30.07.2019 and he has also filed a memo to that effect along with the xerox copy of the Challan before this Court, hence this petition is entertained. Hence, he prays to grant further time to execute the sureties.

3. Heard the learned counsel for the petitioner and the learned Government Advocate(Crl.Side) appearing for the State.

Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Crl.Side), the time granted by this Court in Crl.MP(MD)No.5728 of 2019 in Crl.OP(MD)No.7142 of 2019 dated 27.06.2019 for surrendering before the concerned Magistrate and executing bail bond is further extended by one week from the date of receipt of a copy of this order as a last chance.
