Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records relating to the impugned recovery order passed by the 1st respondent vide Letter NO. Ka.Pa.Ni.2/18583/2013 dated 04.01.2014 and quash the same with respect to the petition and consequently direct the respondents to continue all the increments as per the original pay fixation.
