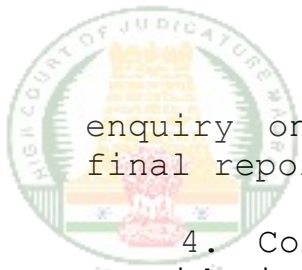

**ORDER**

This petition has been filed to transfer the investigation of the case in Crime No.135 of 2017 pending on the file of the second respondent to some other agency.

2. The grievance of the petitioner is that based on the complaint given by the petitioner a case in Crime No.135 of 2017 for the offence under Sections 341, 387 and 506(2) IPC has been registered. Even though a case was registered on 29.03.2017, so far the investigation is not completed and final report has not been filed. Hence, the petitioner is before this Court with the present petition.

3. The learned Government Advocate (Crl.Side) appearing for the respondents, on instructions, would submit that already



enquiry on the complaint lodged by the petitioner is over and final report will be filed within a period of one week.
