ORDER

This Writ Petition has been filed for issuing a direction to the respondents to pay advance of Rs.1,00,000/- from the accumulation of employee's Contribution Stood in the E.P.F account of the petitioner.

According to the respondents, the petitioner made an application seeking loan amount of Rs.1,00,000/- from his EPF account, for which, the respondents have paid a total sum of Rs.70,000/- (Rs.40,000/- on 03.07.2016 and Rs.30,000/- on 25.08.2018 respectively) as loan to the petitioner under the EPF account. Further, the respondent counsel has also placed a copy of the Letter No. TNSTC / Legal / 1358/2016, dated 01.06.2019 issued by respondents to the petitioner and he has also submitted that nothing survives for adjudication in this Writ Petition.



3. In view of the said submission, this Writ Petition is dismissed as infructuous. No costs.
