PETITION FOR TIME EXTENSION Under Sec.482 of Cr.P.C.

PRAYER :-

To extend the time limit fixed by this Hon`ble Court in Crl OP (MD)No.8263 of 209 dated 14.06.2019 to surrender before the concerned Magistrate to execute the sureties.

ORDER : The Court Made the following order :-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.8263 of 2019, dated 14/06/2019, for producing the sureties and for executing the bail bond.
