PRAYER :-

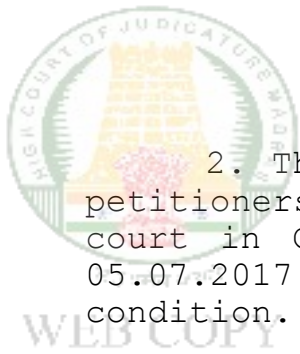
To relax the condition imposed Crl.MP(MD)No.5663/2017 dated 05.07.2017 in Crl.OP(MD)No.2881/2017.
