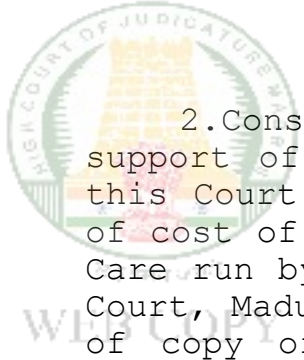
PRAYER IN SA(MD) No.SR48377 of 2017
