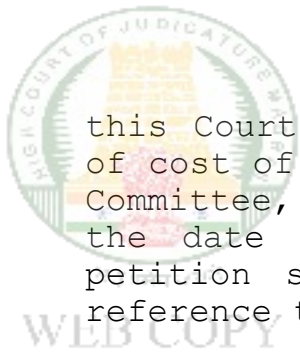
PRAYER IN CMA(MD)No.SR13833 of 2019:
