No costs.

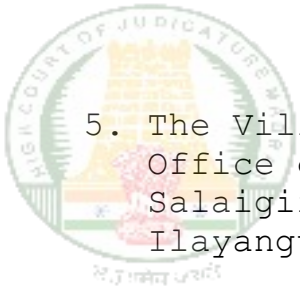
