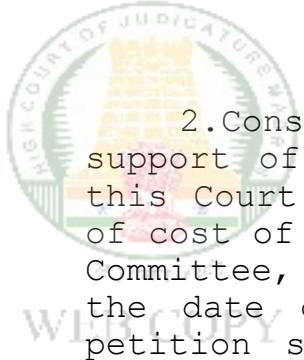
PRAYER IN CMA (MD) No.SR 7989 of 2019
