Prayer Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus, directing the respondents herein to grant permission and give police protection to conduct the Aadal Padal dance program at about 7.00pm on 28.08.2019 in pursuance to the festival of Arulmighu Sri Muthuaramman Thirukovil situated in Melakanam, Vallivilai Post, Tiruchendur Taluk, Thoothukudi District on considering the petitioner's representation dated 08.07.2019.

ORDER

This Writ Petition has been filed seeking a direction to the respondents to grant permission and necessary police protection to perform the cultural program ie., Adal Padal Dance Programme on 28.08.2019 at 07.00 p.m. in the festival of Arulmighu Sri Muthuaramman Thirukovil situated in Melakanam, Vallivilai Post, Tiruchendur Taluk, Thoothukudi District, based on the petitioner's representation dated 08.07.2019.

2.Heard both sides.

3.The grievance of the petitioner is that seeking permission and protection to conduct Adal Padal Programme on 28.08.2019 in the above said temple, the petitioner made a



representation on 08.07.2019 to the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.

4. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 08.07.2019 and pass suitable orders on merits and in accordance with law, forthwith.
