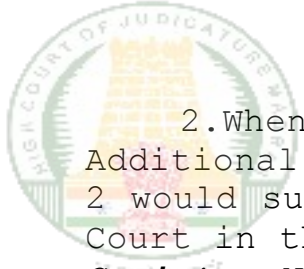

When the matter is taken up for hearing today, the learned Additional Government Pleader appearing for the respondents 1 and 2 would submit that in the light of the decision rendered by this Court in the case of **Marappan Vs. Deputy Registrar of Co-operative Society, Namakkal** reported in **2006 (4) CTC 689**, this writ petition is not maintainable.

3. In view of the submission made by the learned Additional Government Pleader appearing for the respondents 1 and 2, this Writ Petition is dismissed as not maintainable.
