PRAYER IN CMA(MD) No. SR81 of 2018

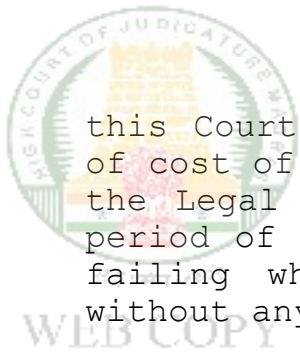
