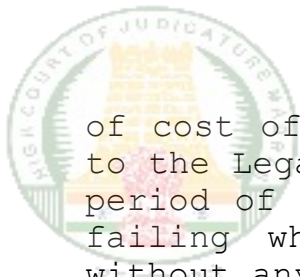
PRAYER IN CMA(MD)No.SR27112 of 2018:
