Prayer in WP(MD) . 5228/ 2019 :

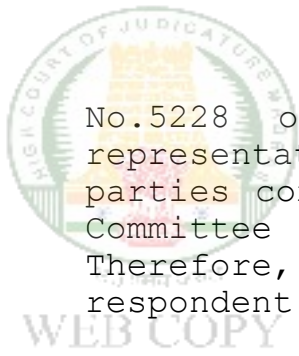
