Prayer in CRL OP(MD). 21361/ 2018 :

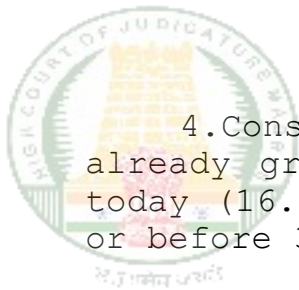

Order : This Original Petition is coming on for orders on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.N.ANANDAKUMAR, Advocate for the petitioner and MR.K.SUYAMBULINGA BHARATHI, Additional Public Prosecutor for the Respondent, the court made the following order:-

This petition has been filed seeking extension of time to pay the cost.

2.Earlier, this Court by an order dated 01.04.2019 made in Crl.O.P.(MD).No.21361 of 2018, directed the petitioner to pay a cost of Rs.3,000/- (Rupees Three Thousand only) to the District Legal Aid Service Authority, Trichy District, on or before 05.04.2019.

3.According to the petitioner, the copy of the order was received by him only on 04.06.2019. He is not in a position to deposit the amount. Hence, he seeks extension of time to pay the cost.
