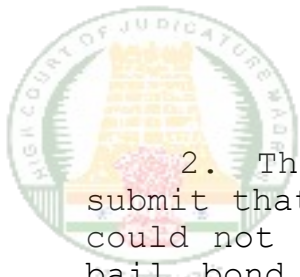
PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

To extend the time limit stipulated in the aforesaid Crl.O.P (MD) No.9073 of 2019 dated 02.07.2019 to surrender before the Learned Judicial Magistrate No.II, Sattur, Virudhunagar District.

ORDER : The Court Made the following order :-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.9073 of 2019, dated 02.07.2019, for producing the sureties and executing the bail bond.

The learned counsel appearing for the petitioners would submit that since they are unable to arrange sureties and hence they could not surrender before the concerned Magistrate and execute the bail bond within the stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.

3. Heard the learned Government Advocate(Criminal Side) appearing for the State.

Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Criminal Side), this petition is ordered and the time for executing the bail bond is extended by one week from the date of receipt of a copy of this order as a last chance.
