PRAYER :-

To Extend the time to surrender and to execute the surety bonds in Crl. O.P.(MD) No. 8283/2019 dated 01/07/2019 in Crime No. 77 of 2019 on the file of the Respondent Police.

ORDER : The Court Made the following order :-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.8283 of 2019, dated 01/07/2019, for producing the sureties and for executing the bail bond.
