This Petition filed under section 482 of Cr.P.C to relax the condition imposed on the petitioners in Crl.A(MD)No.275/2019 dated 05.07.2019.

Prayer in Crl.A(MD)No.275/2019 ;

This appeal is filed under section 14-A(2) of the Scheduled castes and the Scheduled Tribes (Prevention of Atrocities) Act 1989 Amendment Act 1 of 2016 to set aside the order dated 18.06.2019 made in Cr.M.P.No.1453 of 2019 on the file of the Principal Sessions Judge Pudukkottai and enlarge the petitioner on bail in connection with the case in Spl.S.C.No.39 of 2018 on the file of the Principal Sessions Judge Pudukkottai.

This petition is ordered, accordingly.
