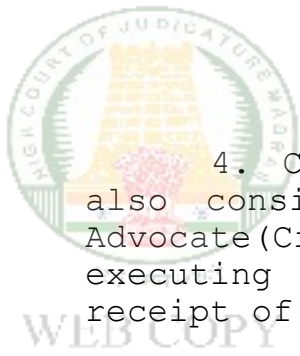
To grant extension of time granted in the order made in Crl.OP (MD)No.8656/2019 dated 20.06.2019 on the file of this Honourable Court.
