3. Mr.K.Suyambulinga Bharathi, learned Government Advocate (Crl. side) takes notice for the respondents.

The grievance of the petitioner is that seeking permission to conduct the cultural programme (ie.,) Adal Padal Dance Programme on 02.08.2019, at 7.00 p.m. to 11.00 p.m. in the Festival of Arulmighu Sri Angalaparameswari Thirukoil at Dharamapuri, Theni District, the petitioner made a representation on 16.07.2019 to the



second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.

5. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 16.07.2019 and pass suitable orders on merits and in accordance with law, forthwith.
