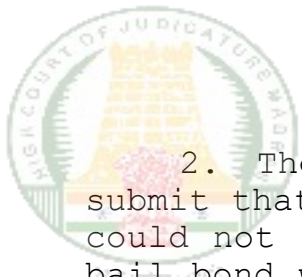
PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

ORDER : The Court Made the following order :-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.8835 of 2019, dated 09/07/2019, for producing the sureties and executing the bail bond.

The learned counsel appearing for the petitioners would submit that since they are unable to execute sureties and hence they could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court.
