2. By consent of both parties, the main Writ Petition is taken up for final disposal at the stage of admission itself.

3. Mr.K.Suyambulinga Bharathi, learned Government Advocate (Criminal side) takes notice for the respondents.

The grievance of the petitioner is that seeking permission to conduct "Adal Padal" Programme on 14.08.2019 at 07.00 p.m. to 11.00.p.m. in connection with "Kodai Vizha" festival of Arulmigu Sri Mariamman Thirukovil, at Salaipudur Village, Sathankulam Taluk, Thoothukudi District, the petitioner made a



representation on 27.07.2019 to the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.
