The grievance of the petitioner is that seeking permission to conduct the cultural programme (i.e) Adal Padal Dance programme on 12.08.2019 at 7.00 p.m. to 11.00 p.m. in the festival of Arulmighu Sri Muthumariamman Thirukovil at Vettivayal, Devakottai Taluk, Sivagangai District., the petitioner made a representation on 17.07.2019 to the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.

5. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representation of the petitioner dated 17.07.2019 and pass suitable orders on merits and in accordance with law, forthwith.

6. The Writ Petition stands disposed of with the above direction. No costs.
