PRAYER:- Writ Petition - filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Certiorarified Mandamus, calling for the records pertaining to the proceedings of the 3rd respondent in No.MD/MDU/97065/M-03/RECY/RO/CP-13/2019 dated 25.06.2019 and quash the same as illegal and consequently, direct the 3rd respondent herein to grant sufficient installments to the petitioner for payment of balance of arrears of contribution of a sum of Rs.2,64,741/- with cost and charges thereof.

ORDER

The petitioner has sought a Certiorarified Mandamus, challenging proceedings dated 25.06.2019 which is a proclamation of sale issued by the Employees Provident Fund Organization.

2. It is seen that the demands consequent on which the proclamation of sale has been made are vide orders dated 09.04.2015 and 22.06.2016. These orders have become final.



3. Thus, I am of the view that this writ petition has absolutely no merit. In fact, the petitioner appears to have filed a representation seeking payments of the admitted arrears in installments. It is for the petitioner to pursue this, if he desires. In any event, the present Writ Petition is devoid of merits and is dismissed. No costs. Consequently, connected Miscellaneous Petitions is closed.
