The second respondent is directed to consider the representations submitted by the petitioner in both writ petitions and conduct due enquiry, after issuing notice to all the rival parties and also after giving opportunity of hearing to all the parties and pass orders in accordance with law forthwith, in view of the order passed by this Court in W.P.(MD)No.19972 of 2019 on 17.09.2019.

5. With the above directions, these Writ Petitions are disposed of. No costs.
