PRAYER :-

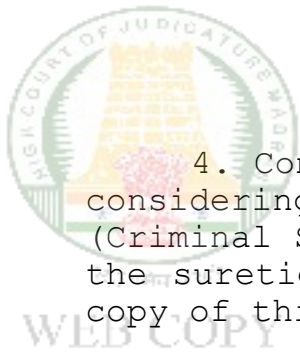
To extnd the time limit granted Crl OP(MD)No.9503 of 2019
