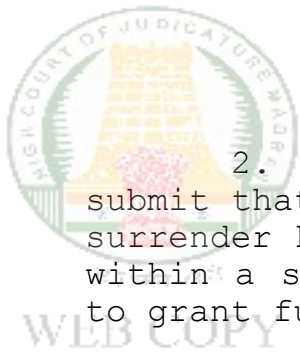
PETITION FOR TIME EXTENSION Under Sec.482 of Cr.P.C.

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.8424 of 2019, dated 02.07.2019, for producing the sureties and for executing the bail bond.
