Prayer in WP(MD) . 7937/ 2010 :

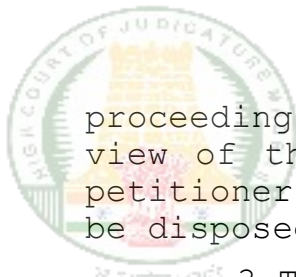
