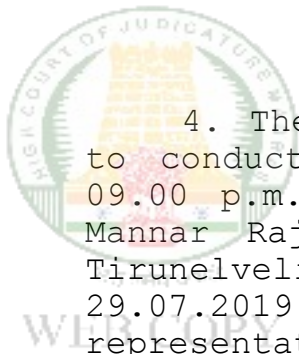

The grievance of the petitioner is that seeking permission to conduct the the "Orchestra Programme" on 14.08.2019 at about 09.00 p.m. to 12.30 a.m. in temple Festival namely "Sri Alagiya Mannar Rajagopal Swami Thirukovil" at Vadakku Vijaya Narayanam, Tirunelveli District, the petitioner made representations on 29.07.2019 and 06.08.2019 to the second respondent and the said representations were not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.

5. Considering the facts and circumstances of the case, without going into the merits of the case, the second respondent is directed to consider the representations of the petitioner dated 29.07.2019 & 06.08.2019 and pass suitable orders on merits and in accordance with law, forthwith.
