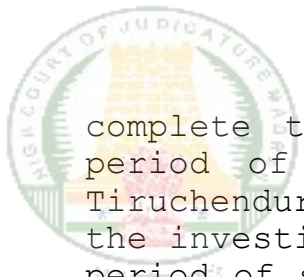
Prayer in Crl OP(MD)No.19580/2018:

Order : This petition coming on for orders on this day and upon perusing the earlier order passed in Crl.OP.No.19580 of 2018, dated 25.01.2019, the petition and the affidavit filed in support thereof and upon hearing the arguments of Thiru.K.Suyambulinga Bharathi, Government Advocate(Criminal Side)for the Petitioners and of Thiru.B.N.Raja Mohamad, for the respondent, this Court made the following order:

This Petition has been filed before this Court under the caption "For extension of time".

2. It is seen from the records, while disposing the petition in Crl.O.P.No.19580 of 2018, this Court by an order dated 25.01.2019 directed the Deputy Superintendent of Police, Tiruchendur to
