Writ Petitions are filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, in the nature of writ, directing the respondent to pay a sum of Rs.59,888/-,Rs.1,42,680/-,Rs.84,904/- and Rs.57,473/- being the difference amount of encashment of earned leave between the encashment of earned leave paid based on the pre revised scale and encashment of earned leave payable based on the revised scale along with 18% interest to the petitioner and to pass such other or further orders.
