PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory bail in Crime No not known of 2019 on the
file of the respondent police

ORDER : The Court made the following order :-

The petitioner apprehending arrest at the hands of the
respondent for the offences under Sections 406 and 420 of I.P.C., in
Crime No. not known of 2019, seeks anticipatory bail.

2.When the matter was taken up for hearing, the learned
Government Advocate (Crl. Side) pointed out that no case has been
registered by the District Crime Branch, Madurai and that the papers
have been sent to Samayanallur Police. Be that as it may, the
allegations set out in the complaint are fairly serious. This is a

case of job racketing. The petitioner is said to have played the role of mediator and collected a substantial sum of money from the defacto complainant. The petitioner's defence is that he had in turn passed on the money to one Kanava Kannan. Since the allegations are serious, the petitioner's role will have to be probed by the police, whether it is District Crime Branch, Madurai or Samayanallur Police. This Court cannot take at face value the statement made by the petitioner. I am not inclined to grant any relief to the petitioner and the criminal original petition stands dismissed.
