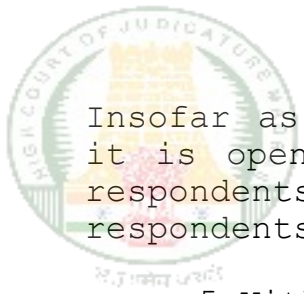
O R D E R

2. By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself.

3.The petitioner has filed an affidavit of undertaking that he will vacate and hand over peaceful possession of the shop to the respondent, on or before 03.11.2019 on completion of Deepavali.

4.Therefore, taking the said affidavit of undertaking on record, a direction is given to the petitioner to surrender vacant possession of the shop to the respondent on or before 03.11.2019.



Insofar as the request for alternative accommodation is concerned, it is open to the petitioner to submit his representation to the respondents. In the event of receiving such representation, the respondents shall consider the same in accordance with law.

5. With the above observation, the writ petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.

6. Post the matter on 04.11.2019 for 'reporting compliance'.
