PRAYER :-

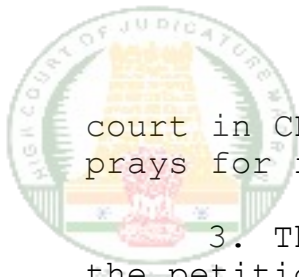
to relax the condition imposed in CRL.OP(MD) No.10124 of 2019
