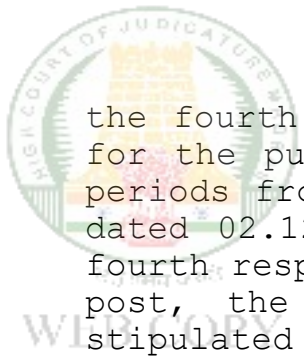

Prayer: Contempt Petition is filed under Section 11 of Contempt of Courts Act, to commit and punish the respondents for contempt of Court for willfully and wantonly disobeyed the order passed by this Court in W.P.(MD)No.15582 of 2017, dated 19.02.2019.

PRAYER in W.P. (MD)No.15582 of 2017:

Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondents to consider the petitioner's various representations dated 06.02.2017, 06.03.2017 and 23.05.2017 and consequently direct



the fourth respondent to send the proposal to the third respondent for the purpose of revising the petitioner's scale of pay for the periods from 23.08.2002 to 27.04.2011 as per the Registrar Circular dated 02.12.2009 issued in Circular No.42 of 2009 and enables the fourth respondent to pay the arrears of revised scale of pay for the post, the petitioner was holding as Secretary within the time stipulated by this Court.
