PRAYER in CRL RC(MD)No.SR5718 of 2019:

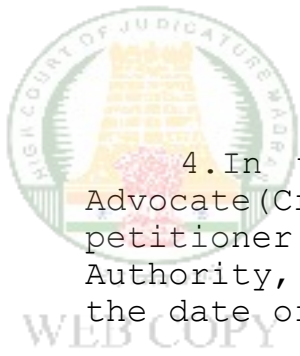
