3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 25.06.2019 stands modified and the petitioner shall appear before the Assistant Sessions Judge, Pattukkottai, at 10.30 a.m. on the first working day of every English calendar month until further orders. All other conditions remain unaltered.
