5.Having regard to the limited scope of the prayer made by the petitioner and considering the submissions made on either side, this Court,

without expressing any opinion on the merits of the case, directs the third respondent to consider the petitioner's representation dated 10.07.2019 on merits and in accordance with law, within a period of six months from the date of receipt of a copy of this order.

6.With the above direction, this Writ Petition is disposed of. No costs.
