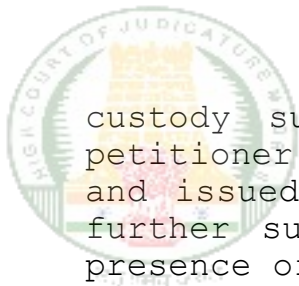
O R D E R

This petition has been filed to direct the fourth respondent not to harass or ill-treat the petitioner and his family members under the guise of enquiry in connection with a civil dispute.

2.The petitioner is arrayed as an accused No.3 in crime No.4 of 2019 for the offences punishable under Section 406 and 420 r/w Section 34 IPC on the file of the fourth respondent.

3.The learned Additional Public Prosecutor would submit that initially the petitioner was arrested and remanded to judicial
