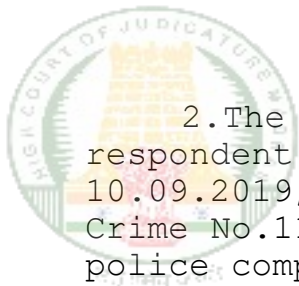
Prayer in CRL OP(MD). 10181/ 2017 :
