This Writ Petition has been filed seeking a direction to the respondents to grant permission and necessary police protection to perform the cultural programme (ie.,) Adal Padal Dance Programme on 27.08.2019 at 07.00 p.m., to 11.00 p.m., in the festival of Arulmighu Sri Muthumariamman Thirukovil at Naduvikkottai, Devakottai Taluk, Sivagangai District.

The grievance of the petitioner is that seeking permission and police protection to conduct the Adal Padal Dance Programme on 27.08.2019 in connection with the festival of the above said temple, the petitioner has given a representation on 24.07.2019 to the second respondent and the said representation was not considered so far.
