Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Certiorarified Mandamus to call for the records pertaining to the impugned order in C.No.E2/16576/17 dated 20/02/2019 and the consequential impugned order in Na.Ka.No.Pa2 / 16576 / 17 dated 08/05/2019 on the file of the respondent NO.2 and quash the same as illegal and consequently for a direction, directing the respondents NO.2 to furnish the statement of witnesses mentioned in the charge memo within the time period stipulated by this Court.

The learned Standing counsel appearing for the respondent Corporation states that the prior statements of the witnesses were not recorded. Therefore, the question of furnishing of those statements will not arise.

2. If the witnesses are to depose straightaway in the regular enquiry, the same will be recorded in the presence of the petitioner. A copy of the statement will have to be given to the petitioner and sufficient time for conducting cross examination also should be given.
