ORDER

This Writ Petition has been filed seeking a direction to the respondents herein to grant permission and to provide police protection to conduct the "Aadal Paadal" dance Programme on 25.08.2019 from 07.00 p.m., to 12.00 p.m., in pursuant to the 'Avani Festival' of Santhanamariamman Thirukovil, situated at Kuttampuli Village, Thoothukudi Taluk and District, by considering the petitioner's representation dated 16.08.2019.

3. The grievance of the petitioner is that seeking permission and police protection to conduct the Aadal Paadal Dance Programme on 25.08.2019 in connection with the 'Avani Festival' of the above said temple, the petitioner has given a representation on



16.08.2019 to the second respondent and the said representation was not considered so far. Hence, the present Writ Petition has been filed for the aforesaid relief.
