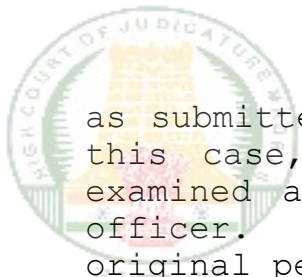

This petition has been filed to quash the C.C.No.201 of 2017 on the file of the Judicial Magistrate, Manappatai, Trichy District as against the petitioner.

2.The learned Government Advocate (criminal side) would submit that in this case, the trial has been commenced and all the witnesses have been examine except the investigating officer.

3.This Court find no merits in the grounds raised by the petitioner to quash the criminal proceedings. The grounds raised in the petition have to be gone into in a full fledged trial. Moreover,
